

His love of music led Vernon to join Radio 1 in 2006 presenting his weekend show until he left the station in 2012. He then fronted his own mid-morning show on the relaunched Radio X from 2015 until 2017.

Vernon has also hosted a number of high-profile entertainment shows across numerous channels. Our 2025 judges



Professor Andy Baker

Professor Andy Baker is a BHF-funded researcher whose work aims to save and improve lives affected by heart disease. In 2022, that mission became personal when his son George suffered a cardiac arrest in a swimming pool. With his daughter's help, Andy performed CPR and saved him. In 2024, he was named a BHF Heart Hero.



Elliot Awin

In December 2023 Elliot set sail from the Canary Islands and went on to row the Atlantic Ocean solo in aid of BHF – the first person to do it with a pacemaker. Elliot was diagnosed with heart condition Wolff-Parkinson-White Syndrome after suffering with episodes of arrhythmia, and had a pacemaker fitted in early 2020. At the 2024 Heart Heroes Elliot received the Hero of the Year award.



James Buchanan

With more than ten years' experience as a senior leader within Laerdal Medical, a long standing and valued partner of BHF, James Buchanan shares our passion for accessible training solutions which can increase survival from out-of-hospital cardiac arrest and improve patient outcomes.



Jeannette O'Neill

Jeanette O'Neill has been supporting the BHF for 8 years and in that time has raised over £12,000. Jeanette began supporting the BHF after losing her 23-year-old brother, Joseph Burns, very suddenly in 2014 to an inherited heart condition which was undiagnosed at the time. Along with fantastic fundraising, Jeanette has bravely shared her family's story multiple times to raise awareness about the importance of the BHF's vital work and to help others.



Jenni Hammond

Jenni is Senior ESG Manager at Royal Mail, leading on sustainability and community programmes, including Royal Mail's partnership with BHF. With experience spanning a variety of sectors, Jenni specialises in unlocking the power of partnerships between charities and business. In March 2023 Lucy woke in the middle of the night to find her newly born, premature twin son Sammie wasn't breathing. She saved his life by performing CPR. Lucy now works as volunteer lead for a local charity, ABC Parents, and teaches CPR in the community. She received a CPR Hero award in 2024.



Mariani Family

Emily and her partner Mathew, from Hendy in Carmarthenshire, were looking forward to life's next chapter when their daughter Esme was born on New Year's Day 2021. 'After a relatively normal pregnancy, the couple thought everything had gone to plan, but they quickly became concerned with Esme's health. After a series of tests, Esme was diagnosed with Atrioventricular Septal Defect (AVSD) and had open heart surgery at Bristol Childrens' Hospital when she was 6 months old. Four years on, Esme doesn't let her condition hold her back. She loves animals, riding her scooter, and has even been skiing!



Professor Mark Kearney

Professor Mark Kearney is BHF Professor of Cardiovascular and Diabetes Research at the University of Leeds. Mark and his team are leading several groundbreaking research projects to develop new treatments for people with type 2 diabetes.

Over an extraordinary year in partnership, Sky Bet has worked side by side with BHF to save lives today, and tomorrow.

This incredible partnership lit up Wembley stadium with powerful campaign messages at two successive Play Off final weekends, put 83 emergency ready defibrillators in communities where they are needed most, and generated an awesome £3 million in donations. Through the Every Minute Matters campaign, we reached millions with our lifesaving message and inspired over 300,000 people across the UK to start learning CPR with BHF's free online interactive tool RevivR.

Next

Next PLC has shown exceptional dedication to the British Heart Foundation (BHF) through a long-standing partnership that spans 18 years of fundraising and nine years of retail collaboration. To date, the partnership has raised over £2.9 million, £1.9 million through furniture donations and over £1 million via Christmas card sales, staff giving, and product collaborations. Their innovative reuse model has diverted 511 tonnes of furniture from landfill, with over 14,000 items donated to BHF stores.

Next's commitment to sustainability, local fulfilment, and circular economy principles is matched by their investment in staff wellbeing and heart health, including rolling out RevivR training to all colleagues and purchasing blood pressure monitors for all stores to ensure their colleagues have access to knowing their numbers.

Outstanding Partner Commitment to Cause



Tesco

This year Tesco and BHF celebrated ten years in partnership, a decade in which we've helped save and improve countless lives across the UK.

With extraordinary commitment to our cause, Tesco has raised an amazing £26 million for BHF, these are vital funds which will help accelerate lifesaving research and empower people nationwide to take control of their heart health. Tesco has also committed to protecting the lives of their customers, staff and communities by installing over 3,000 defibrillators and registering them on The Circuit. In 2024 and 2025 alone, together we offered nearly 10,000 free blood pressure checks to people across the country, promoted heart healthy food choices to Tesco customers, and printed and distributed 850,000 heart health information leaflets. And, as part of the Health Charity Partnership, the Let's Talk programme, continues to support around 1,500 Tesco pharmacy staff to talk to customers about cardiovascular diseases.

This award is for every Tesco colleague and customer, to recognise their outstanding support, which is helping us to build a healthier nation.



CPR Heroes



Hannah & Polly Cooke the dog

Adam Cooke, a fit and healthy runner from Enniskillen, had a cardiac arrest in March 2024, aged 37. He was asleep in bed with his wife Hannah when she was woken by the barking of their golden retriever, Polly, barking downstairs in the kitchen, alerting her to Adam's agonal breathing. Hannah had previously worked as a carer and instantly recognised that her husband was having a cardiac arrest.

She rang the emergency services and immediately rolled Adam off the bed and started CPR. Despite being completely terrified, Hannah managed to stay focused while speaking to the emergency call handler and perform CPR until the ambulance arrived 7 minutes later.

The paramedics continued CPR and used a defibrillator to shock Adam back to life. Adam was in hospital for a number of weeks undergoing investigations and had an ICD and pacemaker fitted.

Adam has thankfully made a full recovery and is incredibly indebted to Hannah for saving his life with her quick actions of starting CPR immediately and calling the ambulance, as well as their dog Polly for alerting her.



Andy Palmer


In January 2024, Andy had a sudden cardiac arrest while working at PureGym. Thanks to the quick actions of a passing ICU nurse, Andy's life was saved with CPR. Just 18 months later, in a remarkable twist of fate, Andy was teaching a spin class when gym member, Andrew, had a cardiac arrest and collapsed. Having completed RevivR training just a week earlier, Andy and his team jumped into action to perform CPR and fetch a defibrillator.

Andrew received four shocks to help restart his heart and was airlifted to hospital. He went on to make a full recovery, and was able to be there for his wedding, just months after the incident. Having lived through a cardiac arrest himself, Andy knows just how critical knowing CPR is — and his courageous response in saving Andrew's life is a powerful reminder of the difference one person can make when they're prepared to act.



Jim Stuart-Young

Gemma's life was saved by her husband Jim after she had a sudden cardiac arrest during a family skiing holiday in Austria. With no warning signs and no known heart condition, Gemma collapsed unexpectedly in their chalet. Thanks to Jim's CPR training through his work, he immediately recognised the emergency and performed CPR for around 20 minutes until paramedics arrived from Innsbruck Hospital. His calm, decisive action kept Gemma alive in a remote mountain resort, giving her the chance to recover and return home. The emotional toll on Jim was immense, yet he remained strong and supportive to his wife and daughters Charlotte and Abi, helping them process the trauma together. Gemma now lives with an ICD and continues to advocate for CPR awareness, inspired by Jim's heroic actions. "Of course I am incredibly grateful, he was amazing". Their story is a powerful reminder of how CPR saves lives and why Jim is their Heart Hero.



Young Heart Heroes



Orla Wray, Young Heart Hero

At just one week old, Orla was diagnosed with doubleoutlet left ventricle (DOLV-fallot type), a rare congenital heart condition. Orla was transferred to Alder Hey Children's Hospital where she underwent open heart surgery to save her life. She has been a vital part of Alder Hey's innovative Little Hearts at Home digital monitoring programme – a platform designed to support families of children with complex heart needs.

Now, as Alder Hey and BHF begin developing the next phase, The Parental Portal, Orla and her family will play a key role in shaping its future. This type of input ensures this technology truly meets the needs of families. With the support of BHF and Alder Hey Children's Charity, Orla's journey is a shining example of how compassion, courage, and collaboration can transform the future of children's heart care.



James Bravery

James, 7, was born with three holes in his heart and a bicuspid aortic valve. He faces a lifelong heart condition with incredible courage, resilience, and strength. Despite experiencing chest pain, tiredness, and shortness of breath, James is determined to live life to the fullest.

After seeing an advert for BHF's Heart Month, he decided to take action – organising a 10-mile sponsored walk around his hometown. His mum, Emma, described it as "heartbreaking and inspiring" to watch him persevere when he felt he couldn't go on. James ended up smashing his £500 target, collecting over £1,350 for BHF. His strength, compassion, and desire to help others make him a true Young Heart Hero, whose bravery deserves to be celebrated by all.

Outstanding Contribution



Shirley West & Maureen Lemin

Shirley and Maureen grew up together in Guilford and have been friends since they were teenagers – even living across the road from each other for 28 years.

Along with raising their children, and watching their grandchildren and great grandchildren grow, these incredible women have also balanced family and work alongside four decades of incredible fundraising for BHF. Shirley and Maureen became involved with the Guildford fundraising group in 1985, after Maureen's father developed heart problems. Over the ensuing years they have helped to raise many millions of pounds for BHF – for everything from community defibrillators across Guilford to funding vital heart-based medical equipment for the Royal Surrey County Hospital.

The ladies have been invited to Buckingham Palace due to their fundraising and volunteering, and in 2013 Shirley was awarded the British Empire Medal (BEM) for services to charity. In 1997 Shirley also became a lifesaver when she saved the life of 17-year-old Clare Reigate after she had a sudden cardiac arrest in the town.

Fundraising Hero



Tim Knight, Tim Fairley & David Kennedy

Tim Knight, Tim Fairley and David Kennedy cycled 1600km from Hollingworth Lake near their homes in Greater Manchester to Italy's Lake Garda, in memory of their dear friend, Simon 'Teddy' Taylor to raise funds for the British Heart Foundation and their local hospice.

Teddy, died aged 56 in 2023 after suffering a heart attack at home. His wife Lisa called 999 and tried to resuscitate him through CPR, but sadly he passed away in the ambulance - leaving Lisa and their young son.

The friends' ten-day 'Lake to Lake Challenge' in May 2024 involved some gruelling mountain passes, cycling more than 100 miles per day. They not only conquered the Alps and paid tribute to their much-loved friend – they raised more than £100.000.

Then in March this year they raised a further £54,000 for both charities through a charity ball. And they're not finished yet. Next year they plan to cycle to the Arctic.

Community Resuscitation Champion



John Deery

John Deery had a cardiac arrest at the Belfast Marathon in May 2024. Thankfully his life was saved by bystanders performing CPR and defibrillation.

Once John recovered, he was determined to make a positive of his story and see an impact with people learning CPR, fundraising for defibs and driving awareness of The Circuit.

John worked with BHF to be at the forefront of The Circuit 100k registrations campaign and during his story, he communicated so eloquently, with integrity and emotion, the importance of having defibrillators that are accessible in public places and registered on The Circuit. His story was picked up by BBC across the UK, making the 6 o'clock news as well as BBC worldwide.

The number of weekly registrations on The Circuit doubled during the week of the John Deery release.

John is also very passionate about encouraging everyone to learn CPR through RevivR and has worked closely with BHF NI, becoming a community champion and working on a number of campaigns, including the launch of Classroom RevivR in schools and the Community Defibrillator Scheme.

Special Recognition Award



Frost Family

In 2015 the Frost family were left devastated when Miles, beloved eldest son of Lady Carina and Sir David Frost, and brother to Wilf and George, passed away.

He was taken from the family without warning, at the age of 31. His death was caused by what was later diagnosed as hypertrophic cardiomyopathy (HCM), a hidden heart condition that can cause sudden cardiac arrest.

Determined to make sure that no other family would suffer as theirs had, Lady Carina, Wilf and George created the Miles Frost Fund. In partnership with BHF, the family raised an incredible £1.5 million to fund 13 additional genetic testing centres across the UK. Staffed by specialist genetic nurses and counsellors, the centres help identify and support family members who have inherited the genes that lead to HCM, saving hundreds of lives. A decade on, we honour Lady Carina, Wilf and George Frost. They have created an extraordinary legacy in Miles' name.

Lifetime Achievement Award



"Supporting BHF research is ... an investment in humanity"

Professor Magdi Yacoub

Professor Sir Magdi Yacoub was only four or five years old when he told his father, "Dad I'm going to be a heart surgeon."

As a child, seeing his beloved father – a general surgeon - struggle to cope with the tragedy of losing his younger sister (Sir Magdi's aunt) at 22 from heart valve disease, he was inspired to devote his life to changing the face of cardiovascular medicine for thousands of patients. This talented surgeon, trailblazing researcher, and tireless charity campaigner has pioneered scientific innovation and saved lives over seven decades. Yet Sir Magdi remains incredibly humble

"My dad fell to pieces when he lost his sister whom he loved so much," Sir Magdi explains. "He told me that there were surgeons in the UK and US starting to open the heart valve and that this disaster could have been prevented. From then, I just followed my dream."

Born in Egypt, Sir Magdi graduated from Cairo University Medical School in 1957. His incredible impact in the field of cardiovascular medicine spans across borders; Sir Magdi has worked and developed cardiac services in many countries including the US, Egypt, Nigeria, Jamaica, Ethiopia, Rwanda and Uganda, alongside the UK. He has worked tirelessly to tackle inequalities in the delivery of global cardiac healthcare.

Sir Magdi served as the first BHF Professor of Cardiothoracic Surgery for more than 20 years and established the largest heart and lung transplantation programme in the world at Harefield Hospital.


His incredible expertise and creativity have led to many medical milestones. He invented and improved several important heart surgeries, including during the 1970s when he pioneered the 'switch' procedure, used to correct a complex congenital heart defect. He operated on Europe's longestsurviving heart transplant patient, performed the UK's first combined heart and lung transplant and carried out the UK's first 'piggyback transplant' - where a donor heart is grafted onto the patient's own failing heart, allowing it the chance to recover.

Of his pioneering surgeries, he reflects: "I was always asking myself what could I do to help a patient who had no other chance of being cured. I would think and think about it... Then when the time came to perform the surgery I knew precisely what I was going to do and more often than not, it did work. There is nothing more exciting that seeing a patient who is about to die or in dire trouble coming to life again.

"When transplantation started, we were greeted with a lot of scepticism ...but now I'm so delighted when a patient comes to see me 36 years after transplantation and brings his children and grandchildren."

On his long-time association with BHF, Sir Magdi says: "Being a BHF Professor of Cardiothoracic Surgery meant a lot to me because I've always admired the research BHF funds. I'm proud to have served the charity for so long. Supporting BHF research is an investment in humanity."

We are thrilled to be presenting Sir Magdi with the first ever Lifetime Achievement Award at the 2025 Heart Heroes. We can think of no more deserving recipient.



"On many occasions, as he operated at Harefield, he played music — usually Bach or Mozart. On this occasion, he worked in silence, retrieving the heart of a woman who had suffered a brain haemorrhage and been certified as brain dead late the previous day. By consenting to be an organ donor when she was alive, she was, unknowingly, helping to save another person and making an important contribution to the future of heart transplants."

Laerdal was founded in 1940 as a children's book publishing and toy company, driven by the mission of "creating children's joy". Over the following years, 100 million of Laerdal's Tomte cars were sold in 100 countries and Laerdal's Anne dolls became popular throughout Europe.

In 1960, following a family drowning incident, founder Asmund Laerdal collaborated with Dr Bjørn Lind and Dr Peter Safar to leveragehis expertise in soft plastics to develop Resusci Anne, a lifelike manikin designed to train the new concept of mouth-to-mouth ventilation.

This innovation marked the birth of Laerdal Medical and a new mission: helping save lives.

From its inception, Laerdal has worked with doctors, nurses, educators, researchers, andleading industry organisations like the British Heart Foundation.

Mutual respect and shared values form the foundation of these relationships; however, the key to long-term success lies in the complementary nature of our missions. Today, more than 500 million people have been trained in CPR, some of them using Resusci Anne, and it is estimated at least 2.5 million lives have been saved.

- 9. All nomination forms must be completed in full to be eligible for inclusion in the process. Incomplete nomination forms will not be processed and for the avoidance of doubt the nominee(s) will not be eligible for an award.
- 10. Nominators shall be responsible for ensuring that the form is fully completed on submission and that all contact details they provide are up to date and accurate.
- 11. BHF reserves the right to change an award category or cancel the Awards at any
- 12. All submitted nominations undergo a review process and our judging panel reserves the right to consider your nominee for an alternative category.
- 13. BHF reserves the right to change the category a person(s) has been nominated for if the submitted nomination details are deemed better suited to another category. In this circumstance BHF will inform the nominator of any changes.
- 14. The BHF panel reserves the right to reject any nomination, including Young Heart Hero or CPR Hero nominations, that does not meet the Awards criteria and/or that do not give enough information about the nominee and why they should receive an award.
- 15. Nominees are shortlisted by the BHF team according to the criteria set against each

- category as stated on the Heart Hero Awards webpages. The shortlist details will be anonymised and then judged by a panel of judges to give an overall winner per category, except Young Heart Hero and CPR Hero categories.
- 16. All CPR Hero and Young Heart Hero nominees, who are eligible for an award following each category criteria, will not be judged and will automatically qualify as a winner.
- 17. All nominees will be notified after the judging process has taken place if they have been shortlisted or unsuccessful.
- 18. The BHF judging panel's decision is final and binding.
- 19. Submitting a nomination does not guarantee that the nominee(s) will receive an invitation to attend the Awards ceremony.
- 20. Winners may be invited to attend the Awards ceremony and BHF reserve the right not to invite winners to attend the Awards at their discretion.
- 21. BHF reserves the right at their discretion to withdraw an award from any confirmed winner before or after the Award ceremony without giving notice of any reason.
- 22. Submitting a nomination does not guarantee that the nominee(s) will receive an award or an acknowledgment from BHF.
- 23. Information that is submitted as part of a nomination may be included on the BHF website, with exception of contact details.
- 24. It is the nominator's responsibility to obtain permission from the nominee before submitting the nominee's personal details and information as requested in the online nomination form.
- 25.Once a nomination is submitted, BHF will contact the nominee to inform of their nomination and ascertain if they are happy to progress it further.
- 26. By submitting a nomination, and if you are the nominee and do not object following contact under point 23 (if you are over the age of 18), you will be deemed to have accepted these terms and conditions for yourself and the nominee (if under 18).
- 27. Personal data collected will be used for the consideration and awarding of the Awards, including to contact nominees and nominators to verify the information. We may also use a nominee's story for media/press activity, our website and/or social media, with the nominee's consent.

- 29. Eligible winners will be encouraged to share their award publicly and may be contacted with the option to feature in BHF promotional activity (including media, etc).
- 30.BHF may contact nominees and winners at any time with the option to be involved in campaign or promotional work outside of the Heart Hero Awards.
