

Cardiovascular Disease (CVD) in Gwynedd Maldwyn

CVD is an umbrella term that describes all diseases of the heart and circulatory system. It includes everything from conditions that are inherited or that a person is born with, to those that develop later, such as coronary heart disease, atrial fibrillation, heart failure, stroke and vascular dementia. In Wales, it's estimated that over 400,000 people are living with CVD.

Person Mortality

In this constituency cardiovascular disease causes **nearly 3 in 10 deaths**

That's **57** deaths each month and **680** deaths each year.

Person Prevalence

The number of people living with major cardiovascular conditions is growing.



There are around **26,000** people in this constituency living with cardiovascular disease, including:



7,292 with coronary heart disease - the main cause of heart attacks



3,066 diagnosed with heart failure



4,951 survivors of stroke

Medical Risk Factors



36,465 people in this constituency have been diagnosed with high blood pressure (hypertension). More than half of heart attacks and strokes are associated with it.



5,732 people in this constituency have been diagnosed with atrial fibrillation (AF). People with AF are up to five times more likely to have a stroke.

Obesity (High BMI)



25% of adults in this constituency have a body-mass index (BMI) defined as obese (30+).

Person Air Pollution



Each year around **1,800 deaths** in Wales are associated with particulate matter pollution - **two in five** of them due to cardiovascular disease.

Smoking



8% of adults in this constituency are cigarette smokers, which is still above the Wales smoke-free target of 5% by 2030.

Out-of-Hospital Cardiac Arrest (OHCA)

Cardiac arrest is the ultimate medical emergency, when the heart suddenly stops beating.



There are more than **2,800** out-of-hospital cardiac arrests in Wales each year. **Just 1 in 20** people survive.

At BHF Cymru, we work with patients, clinicians, charity partners, and the Senedd and Welsh Parliament to support people affected by cardiovascular disease in Wales.

We need bold action from Welsh Government to ensure that we prevent heart disease where possible, and help people live well, for longer.

 **5,732** o bobl yn yr etholaeth hon wedi cael diagnosis o ffibriliad atrïaidd (AF). Mae pobl ag AF hyd at bum gwaith yn fwy tebygol o gael strôc.


📊 Gordewdra (BMI uchel)

 Mae gan **25%** o oedolion yn yr etholaeth hon gyda BMI a ddiffinnir fel gordew (30+).

🫁 Llygredd Aer


 Bob blwyddyn mae tua **1,800** o farwolaethau yng Nghymru yn gysylltiedig â llygredd deunydd gronynnol – dau o bump ohonyn nhw o ganlyniad i glefyd cardiofasgwlaidd.

🚬 Smygu

 Mae **8%** o oedolion yn yr etholaeth hon yn smygu, sydd dal yn uwch na tharged di-fwg Cymru o 5% erbyn 2030.

🚑 Ataliad y Galon y Tu Allan i'r Ysbyty (OHCA)

Ataliad y galon yw'r argyfwng meddygol mwyaf difrifol, pryd mae'r calon yn stopio curo.

 Yng Nghymru, bob blwyddyn, mae yna dros **2,800** o achosion o ataliad y galon y tu allan i'r ysbyty. Dim ond **1 o bob 20** o'r bobl hyn sy'n byw.

Mae BHF Cymru'n cydweithio â chleifion, clinigwyr, partneriaid elusennol, a'r Senedd a Llywodraeth Cymru i gefnogi pobl y mae clefyd cardiofasgwlaidd yn effeithio arnynt.

Mae angen i Lywodraeth Cymru weithredu'n eofn i sicrhau ein bod yn atal clefyd cardiofasgwlaidd rhag datblygu lle bo modd, ac yn helpu pobl gael bywyd o ansawdd da, am fwy o amser.
